

REPORT OF THE MEETINGS ON CITIZENS' ENGAGEMENT ON THE YEAR 2019 BUDGET HELD AT THREE(3) SENATORIAL DISTRICTS OF THE STATE OF OSUN, FROM TUESDAY 22ND TO THURSDAY 24TH OCTOBER, 2018.

1.0 INTRODUCTION

1.1 In its continual efforts to ensure inclusiveness, sustainable and all round development of the State of Osun, the Ministry of Economic Planning, Budget and Development rolled out three days interactive sessions with stakeholders on socio-economic development of the State. The need for the engagement became imperative with belief that government exists for the people and the limited resources available should be efficiently allocated to meetyearnings of the citizenries.

1.2 The meetings also created a platform to engage the citizens of the State and harvest their inputs towards the preparation of 2019 Budget. For Osun East and West Senatorial Districts, the meetings were held at Damol Events Centre Ilesa and CEE BEE Hotel Iwo respectively, while that of Osun Central was held at Ideal Nest Hotel, Osogbo.

2.0 ATTENDANCE

The participants invited across the three Senatorial Districts of the State (Osun East, West and Central) were Traditional Rulers, Religious Organisations, Civil Society Organisations (CSOs), Non-GovernmentalOrganisations (NGOs), Market Women Associations, Market Men Associations, National Association of Road Transport Workers, Okada Riders' Association, Youths Organisation, representative of Political Parties, Media Groups, representatives of Ministries, Departments & Agencies (MDAs) of government, Labours' Unions, Organized Private Sectors (OPSs), Farmers, Religious Leaders (Christians & Muslims) and other relevant stakeholders, farmers religious leaders (Christians, Muslims and Traditional religious).

3.0 OPENING

- **3.1**Throughout the periods, the meetings commenced at 10am.
- **3.2 Welcome Remarks:** In his welcome remarks, the Permanent Secretary, Ministry of Economic Planning, Budget and Development, Mr. SegunOlorunsogo explained that the stakeholders' meeting was a part of the government visions to bestow upon the State a legacy of inconclusive governance where people will always be carried along in the Budget Process. He appreciated the participants for their sacrifice and unflinching supports toward the betterment of the State.
- 3.3 He spoke furtherthat citizenconsultative meeting was an avenue for people to have inputs in the programmes and projects of government to be captured in Year2019 Budget. He therefore charged the participants to contribute meaningfully because their inputs are germane to successful implementation of 2019 Budget. He therefore wished participants fruitful, peaceful and successful deliberations.
- 3.4Opening Remarks: In his opening remarks, the Hon. Commissioner, Ministry of Economic Planning, Budget and Development (MEPBD), Dr. Olalekan Yinusathanked the Executive Governor of the State; Ogbeni Rauf Adesoji Aregbsola for the visionary style of governance in the State. He recognised and appreciated the participants especially the religious leaders, former State Chairman of NUJ, State Chairman of TUC, Iyalojas, and Chief Registrar of High Court of Justices, CSOs, NGOs, Media Groups, and representatives of MDAs that were present.
- 3.5 He explained that the reasons for calling the meetings were to allow citizens to:
 - have inputs in year 2019 Estimates;
 - make year 2019 Estimates is as all inclusive as possible and
 - act as a monitoring stakeholders so that government can have adequate feedback.
- **3.6** The Hon. Commissioner further reiterated the unwavering determination of the Governor-elect of the State of Osun, Mr. Gboyega Oyetola to socio-economic development of the State.
- 3.7 He said the implementation of the 2019 Budget would provide an overall policy framework for sectoral implementation and service delivery. According to him, the Budget intended to provide a comprehensive framework for sustaining the development in the State of Osun in the next 365days. He explained further that

the programme was also designed to reduce poverty, provide more infrastructural development and efficient management of resources in the State.

3.8 He stressed that engagement of the citizens in policy formulation would further help the State to identify the priority programmes and projects needed to be initiated for people of the State. He then charged all stakeholders to support the government to achieve its goals, adding that everyone has role to play in securing a brighter and sustainable future for the State. He therefore congratulated the participants for being part of the historic events.
