1 Summary of Performance

1.A Introduction

The Budget Performance Report for Osun State is prepared quarterly and issued within 4 weeks from the end of each quarter.

This report includes the original approved budget appropriation for the year 2022 against each organizational unit of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual revenues and expenditures for the Quarter Two (Q2) attributed to each Ministries, Departments and Agencies (MDAs); as well as the cumulative actual revenue and expenditures for the year to date; and balances against each of the revenue and expenditure appropriations.

This Q2 report is assessed against the 2022 Approved budget.

The core economic classifications refer to:

- Personnel – Economic Sub-Account Type 21
- Overheads - Economic Account Class 2202
- Capital - Economic Sub-Account Type 32
- Others - Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Ministry of Economic Planning, Budget and Development, in conjunction with the Office of the Accountant-General, Osun State and published on the Osun State website <https://www.osunstate.gov.ng/resources/budget-documents/>

1.B Revenue Performance

The Revenue comprises of the:

- i. Recurrent Revenue
- ii. Capital Receipts

In the 2022 Approved Budget, the Total Revenue was projected to be ₦129,756,450,790.00. The actual revenue from January to March 2022 (Q1) was ₦34,468,108,735.14 which gives a Revenue performance of 26.6% while the Actual revenue from April to June 2022 (Q2) is ₦26,320,461,702.57 resulting to a total actual revenue (Q1-Q2) of ₦60,788,570,437.71 which gives a Revenue performance of 46.8% and also resulting to a variance of ₦68,967,880,352.29 as at the end of second quarter (Q2).

The 2022 Recurrent Revenue Budget was projected to be ₦87,923,692,250.00. In the First Quarter (Q1), the actual recurrent revenue was ₦19,344,073,514.05 resulting to a Performance of 22.0% while the actual revenue from April to June 2022 (Q2) is ₦23,080,966,497.91 resulting to a total actual revenue (Q1-Q2) of ₦42,425,040,011.96 which gives a revenue performance of 48.3% and resulting to a variance of ₦45,498,652,238.04 as at the end of the second quarter.

As at the second quarter (January – June 2022), the Government share of FAAC which forms part of the recurrent revenue was projected to be ₦52,450,000,000.00 has an actual of ₦28,721,536,384.19 resulting to a performance of 54.8% while the Independent Revenue projected to be ₦35,473,692,250.00 has an actual of ₦13,703,503,627.77 resulting to a Performance of 38.6%.

Some revenue items (Exchange Rate Gain, Excess Bank Charges and Interests) which were not budgeted for earned the State some income between January and June. This resulted in improved budget performance during the quarter. Meanwhile, necessary steps will be taken to revise the budget before the end of the Third Quarter in order to capture these items.

Some IGR revenue items such as Health Facility Licenses, Accreditation fees, Sales of Application forms and Earnings from Consultancy/Professional Services have over performed in the Second Quarter due to high patronage in their various areas.

The Capital Receipts was projected to be ₦24,306,975,530.00 with an actual of ₦1,208,260,775.00 in the First Quarter (Q1) and rose to ₦4,447,755,979.66 resulting to a performance of 18.3% in the Second Quarter Q2 (January – June). The State Government hopes to achieve higher performance by engaging the anticipated partners into the State for financial support.

1.C Recurrent Expenditure Performance

The Recurrent Expenditure is divided into:

- i. The Personnel Cost
- ii. Other Recurrent Expenditure

The 2022 Recurrent Expenditure Budget was projected as ₦53,893,627,990.00 with an actual of ₦13,865,503,832.77 for the Q1. In the Second Quarter (Q2), the actual recurrent expenditure increased to ₦26,027,405,780.69 which results to a performance of 48.3% (Q1-Q2) giving a variance of ₦27,866,222,209.31.

The Personnel cost was projected to be ₦36,384,933,170.00 with an actual of ₦9,747,219,137.21 for the Q1 while in the second quarter, the Actual personnel cost increased to ₦19,876,839,699.72 which results to a performance of 54.6% (Q1-Q2) giving a variance of ₦16,508,093,470.28. Some Ministries, Department and Agencies (MDAs) have overspent their personnel budget as a result of deployment of staff from various MDAs and this led to an increase in personnel cost of such MDAs. Notwithstanding, payment of salaries is centralized in the State.

The Other Recurrent Expenditure was projected to be ₦17,508,694,820.00 with an actual of ₦4,118,284,695.56 for the Q1 while in the second quarter Q2, the actual other recurrent expenditure increased to ₦6,294,245,089.75 which resulted to a performance of 35.9% with a variance of ₦11,214,449,730.25.

1.D Capital Expenditure Performance

The Capital Expenditure was projected to be ₦ 75,862,822,800.00 with an actual of ₦10,636,407,093.98 for the Q1. In the second quarter Q1-Q2, the actual capital expenditure rose to ₦22,189,111,786.28 with a performance of 29.2% giving a variance of ₦ 53,673,711,013.72. The Capital expenditure performance seems to be low because there are no enough capital receipts to fund some capital projects.

1.E Conclusions

In Conclusion, the total budget size for 2022 was projected to be ₦129,756,450,790.00 giving an actual revenue performance of ₦60,788,570,437.71 as at the second quarter with the corresponding expenditure performance for the period as ₦48,360,196,575.74. This represents 46.8% for Revenue and 37.3% for Expenditure.

A supplementary / reallocation of budget will be prepared before the end of Quarter 3 to make provisions for all MDAs that are in dare need of more fund.
